IV. PRM DIRECTOR UPDATE

PRM Director Brent Dennis provided the Board with a summary of department activities, programs, & projects.

Long Beach fiscal year 2020/21 budget approved. Overall PRM budget cuts totaled 3%, allocation included an increase in funding for irrigation for all facilities, an additional park ranger position for Bixby Park, and funding for municipal concerts

PRM Administrative office was closed temporarily due to COVID-19 cases among staff

PRM staff was out in the community during Labor Day weekend to assist with COVID-19 operational compliance at recreation facilities

CARES Act Funding approved to support Mobile Recess Program starting soon with expanded virtual programs

PRM staff will be taking 26 furlough days every other Friday throughout the fiscal year starting in October as part of the budget cuts

V. POP VIRTUAL CONCERT DEBRIEF

Executive Director Rowsell provided an update on the POP Virtual Concert held September 12th with Elm Street Band

Sponsors included Azteca Landscape, International City Bank, Long Beach CVB, MemorialCare Long Beach Medical Center/Miller Children's Hospital Long Beach, Parkwood Landscape, Port of Long Beach, & Signal Hill Petroleum.

Over 410 concert views in Vimeo, \$6,600 in donations received, including \$1,500 from individuals, Costs (\$1065), Net proceeds \$5,585 from event

Last minute switch of platforms from YouTube to Vimeo due to copyright issues was the only glitch. Good press prior to the event was received, editing for the event with interviews intermingled was a nice bonus, overall a very professional product.

Replay of the concert will be permitted from our website through the end of October for promotional purposes and to solicit additional donations.
